D. APPROVAL OF MINUTES

N/A- Moved to next meeting, March 25, 2010 6 pm to approve both 1-14-10 and 2-11-10 meeting minutes at that time.

E. PUBLIC COMMENTS – Comments concerning items not on the agenda

Pursuant to A.R.S. § 38-431.01 (G), action taken as a result of the Public Comment is limited to (1) asking staff to study the matter, (2) responding to, or (3) asking individual criticism that the matter be placed on a future agenda.

F. ITEMS FOR DISCUSSION/POSSIBLE ACTION

1. How to handle use of Alternates (Vice Councilors) to cover Councilors when missing from meetings.
 - Anthony Smith moved to allow Vice Councilors (in specific order, and when Councilor is missing from meeting), to take Councilor's place and reside during the meeting. Should the Councilor show up late, said Councilor will take seat in the Vice- Councilor seat. Seconded by Payton Pettet. Votes unanimous, 7-0.

Staff Advisor will keep a list of Vice-Councilor substitutions so that there will be equal opportunity for them to replace Councilors.

2. Surveying peers to assist in identifying goals/ objectives of PAYC this year.
 - Anthony Smith moved the subject of: flyers, petitions, a student survey, discussing ideas with RCMS and PHS until the next meeting, March 25, 2010. Seconded by Alicia Bayless. Votes unanimous, 7-0.
3. Media and promotion of PAYC to peers.
 - Subject of PAYC's own MySpace and/or Facebook page, how we would deal with privacy, avoiding informal meetings, etc. Motion made by Sam Grassel, seconded by Anthony Smith, for Vice Councilor, Dillon Walker, to do initial research in forming either web page for PAYC for future discussion at next meeting, March 25, 2010. Votes unanimous, 7-0.
 - Subject of PAYC's own email brought up by Payton Pettet. Motion made by Anthony Smith, seconded by Payton Pettet, to form a Town of Payson email account for PAYC. Votes unanimous, 7-0.
4. Idea of indoor skating rink at the Old Dollar General Store
 - Group held discussions on feasibility of having the Old Dollar General Store as an indoor skating rink, and felt that it needed future discussion on utilizing this facility or alternative facility for teen use at the next meeting. Motion was made by Anthony Smith, seconded by Sam Grassel, to move a more general discussion of potential sites for teen uses to the March 25, 2010 meeting. Votes unanimous, 7-0.
5. Future meeting dates for remainder of school year:
 - a. March 25th (due to Spring Break coinciding with 2nd Thursday of the Month); April 8th – Mary McMullen spoke on subject, moved to fourth Thursday of April. Moved by Anthony Smith, seconded by Lauren Best. Votes unanimous, 7-0
 - b. Change in day of week for May meeting – only choices are Tuesday, May 4th, or Monday, May 10th for Payson Town Hall location – Group undecided. Anthony Smith made a motion to move discussion on rescheduled meeting date to next meeting, March 25, 2010. Votes unanimous, 7-0.
