-A poll will be taken at school registration. Tyler Aguirre is going to check registration dates.

-The date set for the concert is October 15, 2011. Tyler Aguirre is going to talk to Parks and Recreation about vendors. Two bands are being mainly considered: Fall Away and 66 Studios. Fall Away will amount to a cost of around 800 dollars and 66 Studios has offered to perform for only the cost of fuel to travel between Payson and Flagstaff for the event. Until a band has been decided on, Dillon Walker will make a mystery band flyer, altering the flyer once action has been taken.
