 - *Tyler Aguirre nominated Dillon Walker for Chairperson, seconded by Alicia Bayless. Anthony Smith nominated himself for Chairperson, seconded by Austin Shannon. Six of the seven councilors voted in favor of selecting Dillon Walker as the new Chairperson (Dillon Walker abstained from the vote.*
 - *Dillon Walker nominated Alicia Bayless for Vice Chairperson, seconded by Austin Shannon. Anthony Smith nominated Austin Shannon for Vice Chairperson, seconded by Lauren Best. The motion to select Austin Shannon as Vice Chairperson passed unanimously.*
 - *Anthony Smith nominated Tyler Aguirre to continue as Secretary, seconded by Austin Shannon. Tyler Aguirre nominated Sam Grassel for Secretary, seconded by Austin Shannon. The motion to select Tyler Aguirre as Secretary passed unanimously.*
3. New PAYC shirts
 - *The PAYC members provided the PAYC Advisor with their shirt sizing for an order of new polo shirts to be placed with Tonto Silk Screen. (No action)*
4. Scoops invoice from Relay for Life
 - *Scoops has presented Lauren Best with an invoice for beverages provided at the Relay for Life event. Lauren will bring the invoice to the Kelli Schwein so the funds can be request from Friends of Payson Parks & Recreation. (No action)*
5. Review 2010 PAYC Fall Concert and plan for 2011 PAYC Fall Concert
 - *Vendors such as Scoops, Optomist Club, Kiwanis, and Aromez Smoothies were suggested for food concession stands. It was a consensus that free activities should be organized such as a tug of war event. (No action)*

 - *PAYC discussed who would attend the AZ League of Cities and Towns on 08/31/2011. It was a consensus that those who did not attend last year, including the three new PAYC members, would be given the opportunity to go if they are all able. Alicia Bayless, Sam Grassel, and Anthony Smith each stated that they will be unable to attend if any of the councilors who were given first priority cannot attend. The name of each remaining councilor was drawn randomly by Su Connell. If any of the councilors who were given first priority cannot attend the event, Lauren Best will first be given the option to attend, followed by Tyler Aguirre. (No action)*
