G. ITEMS FOR DISCUSSION/POSSIBLE ACTION

1. Shelia DeSchaaf, General Plan Update

- Shelia Mentioned the importance of the feedback from the public on critical issues and the importance of Parks Commission feedback on the priorities and strategies for the general plan update. She also informed the commission of the upcoming General Plan meeting available for attendance that week at the Payson Public Library.

2. Future Development of the Stewart Pocket Area.

- All present members of the Commission reached an agreement to hold this discussion until the next meeting for Chairman, Rob Ingrams presence and knowledge on the subject and area.

3. Special Event Updates

A. Eggstravaganza

- The Eggstravaganza is a co-sponsored event that is ran by the Kiwanis Club, This event is successful year to year for the children to hunt eggs. This year there was an attendance of about 700 children.

B. Optimist Fishing Festival

- The Optimist Fishing Festival is a co-sponsored event suffering with a lower turn out this year for un-known causes.

C. Beeline Cruise In Car Show

- The Beeline Cruise-In is a co-Sponsored event, a huge success and always well attended, this year with an estimation of 3,000 people.

D. Harlem Ambassadors

- This was a first year, very enjoyable event. The performance was noted to possibly be more successful if it were not annual, but more so irregular.

E. Wildlife Fair

- The Wildlife fair is a co-sponsored event with the Arizona Game and Fish Department. This event, year to year, is successful. The wildlife fair also attracts several out of town residents as well.

4. Upcoming Special Events

A. Mountain High Games / Mogollon Monster Mudder

- First year with the Mudder, Estimated 300 runners for attendance.

B. Sprint Triathlon

-Year to year a largely successful event with an estimation of near 200 participants.

C. Concert Series

-This event is free to the public and ranges in attendance from 300-1,500 spectators per night.

D. 4th of July

-This event is Payson's largest and most well attended event with estimated attendance assumed to be higher this year due to the Thursday, at nearly 10,000.

C. Arizona High School Rodeo Assn.

- AHSRA is a returning event with an attendance near 400 contestants, not including family.

D. USTRC – Payson Event Center

- USTRC is a new team roping event upcoming to Payson, with an estimated 700-1000 participants.

E. ASU

- ASU holds a week of Football practice open for the public to attend, This event is during August Rodeo and is also beneficial to the town to bring in spectators as well as revenue.
