

RESOLUTION NO. 2155

A RESOLUTION OF THE MAYOR AND COMMON COUNCIL OF THE TOWN OF PAYSON, ARIZONA, DECLARING AND ADOPTING THE RESULTS OF THE PRIMARY ELECTION HELD ON MARCH 14, 2006, AND DECLARING AN EMERGENCY.

WHEREAS, the Town of Payson, Gila County, Arizona, did hold a primary election on the 14th day of March, 2006 for the nomination/election of a mayor and three council members, and did cause to be submitted to the qualified electors of the Town the following question:

Shall the Mayor of the Town of Payson be elected for a four (4) year term instead of the current two (2) year term? and

WHEREAS, the election returns have been presented to and have been canvassed by the Mayor and Common Council of the Town of Payson,

NOW, THEREFORE, THE MAYOR AND COMMON COUNCIL OF THE TOWN OF PAYSON, ARIZONA, DO HEREBY RESOLVE AS FOLLOWS:

Section 1. That the total number of ballots cast at said primary election was 5153.

Section 2. That the number of ballots to be verified was 0 and the number of voters found to be ineligible was 76.

Section 3. That the votes cast for the candidates for the office of Mayor were as follows:
