

RESOLUTION NO. 2156

A RESOLUTION OF THE MAYOR AND COMMON COUNCIL OF THE TOWN OF PAYSON, ARIZONA, AMENDING SECTION 150.20 (INTERNATIONAL RESIDENTIAL CODE) OF THE CODE OF THE TOWN OF PAYSON AND DECLARING SUCH AMENDMENT TO BE A PUBLIC RECORD.

WHEREAS, the Code of the Town of Payson was declared to be a public record by Resolution Number 1536 of the Town of Payson; and

WHEREAS, the Code of the Town of Payson was adopted as a public record by Ordinance Number 588 of the Town of Payson; and

WHEREAS, it is the intention of the Town of Payson to amend Section 150.20 (International Residential Code) of the Code of the Town of Payson; and

WHEREAS, such amendment may be enacted by reference, pursuant to A.R.S. § 9-802,

NOW, THEREFORE, THE MAYOR AND COMMON COUNCIL OF THE TOWN OF PAYSON, ARIZONA, DO HEREBY RESOLVE AS FOLLOWS:

Section 1. Section 150.20 (International Residential Code) is hereby amended to add Subsection 150.20(B)(17) and as added, Subsection 150.20(B)(17) shall read as follows and is declared to be a public record:

§150.20(B)(17) Section R602.10.6 is deleted and is replaced by Sections R602.10.6.1 and R602.10.6.2 and Figure R602.10.6.2 of the 2004 Supplement to the International Building Code.

Section 2. Sections R602.10.6.1 and R602.10.6.2 and Figure R602.10.6.2 of the 2004 Supplement to the International Building Code, set forth in Exhibit A, attached hereto, are made a part hereof by this reference as though set forth in full at this point, and are declared to be a public record.

Section 3. If any section, subsection, sentence, clause, phrase or portion of Resolution Number 2156 is for any reason held to be invalid or unconstitutional by the decision of any court of competent jurisdiction, such decision shall not affect the validity of the remaining portions of Resolution Number 2156. The Town Council of Payson declares that it would have adopted Resolution Number 2156 and each section, subsection, sentence, clause, phrase, or portion thereof, irrespective of the fact that any one (1) or more sections, subsections, sentences, clauses, phrases, or portions may be declared invalid or unconstitutional.
