

RESOLUTION NO. 2184

A RESOLUTION OF THE MAYOR AND COMMON COUNCIL OF THE TOWN OF PAYSON, ARIZONA, DECLARING AND ADOPTING THE RESULTS OF THE GENERAL ELECTION HELD ON MAY 16, 2006, AND DECLARING AN EMERGENCY.

WHEREAS, the Town of Payson, Gila County, Arizona, did hold a General Election on the 16th day of May, 2006 for the election of a Mayor, three Council Members and Proposition 300; and

WHEREAS, the election returns have been presented to and have been canvassed by the Mayor and Common Council of the Town of Payson,

NOW, THEREFORE, THE MAYOR AND COMMON COUNCIL OF THE TOWN OF PAYSON, ARIZONA, DO HEREBY RESOLVE AS FOLLOWS:

Section 1. That Exhibit A, attached hereto and incorporated herein, is adopted as the Official Town of Payson Canvass/Abstract of Vote for the General Election of May 16, 2006 and that Exhibit B, attached hereto and incorporated herein, is adopted as the May 16, 2006 General Election Summary Report.

Section 2. That the total number of ballots cast at said General Election was 5393.

Section 3. That the number of ballots to be verified was 0 and the number of voters found to be ineligible was 32.

Section 4. That the votes cast for the candidates for the office of Mayor were as follows:
