

RESOLUTION NO. 2240

A RESOLUTION OF THE MAYOR AND COMMON COUNCIL OF THE TOWN OF PAYSON, ARIZONA, APPROVING THE APPOINTMENT OF DR. AL POSKANZER AS A TEMPORARY MEMBER OF THE TOWN OF PAYSON PERSONNEL BOARD.

WHEREAS, Ordinance No. 305 creates a three-person personnel board for the Town of Payson; and

WHEREAS, Section 33.02 (C) of the Town Code of the Town of Payson provides that members of Town boards shall be appointed by the Mayor and approved by the Town Council; and

WHEREAS, the Town Personnel Board will be called upon to conduct one or more personnel hearings in the beginning of the year 2007; and

WHEREAS, it is important to preserve fairness in Town personnel hearings,

NOW, THEREFORE, THE MAYOR AND COMMON COUNCIL OF THE TOWN OF PAYSON, ARIZONA, DO HEREBY RESOLVE AS FOLLOWS:

Section 1. That Dr. Al Poskanzer, appointed by F. Robert Edwards, Mayor of the Town of Payson, to the Personnel Board, is hereby approved as a member of the Personnel Board for the purpose of any and all hearings to be held involving the Police Department during the year of 2007.

Section 2. That Mrs. Deborah Vaughn shall remain a member of the Personnel Board for the Town of Payson for all other purposes, except for personnel hearings involving the Town Police Department during the year 2007 and that she shall not participate in such hearings.

Section 3. That the number of members of the Personnel Board shall remain constant at three (3) members.

Section 4. That any ordinances or resolutions in conflict with the provisions of this Resolution No. 2240 are hereby repealed to the extent of such conflict.

Section 5. If any section, subsection, sentence, clause, phrase or portion of this Resolution Number 2240 is for any reason held to be invalid or unconstitutional by the decision of any court of competent jurisdiction, such decision shall not affect the validity of the remaining portions of this Resolution.
