## POSSIBLE MOTION

I move to approve changing the name of West Ashby Circle to West Cottage Creek Court contingent upon the developer installing the revised street name sign.

## SUMMARY OF THE BASIS FOR POSSIBLE MOTION:

The Cottage Creek Subdivision is an 11 lot single family subdivision located at the southeast corner of Colcord Road and Longhorn Road. Ashby Circle is a short cul-de-sac road serving 11 lots and is the only internal street in this subdivision. Currently all 11 lots are vacant. We have received a request from the current owner of this subdivision, Glen Whitlock, (all 11 lots) to change the street name from West Ashby Circle to W. Cottage Lane. A copy of the request letter is attached. Since this is a cul-de-sac the new name must be a "Circle", "Court", or "Point" to comply with the Towns Street Naming convention. After discussing this issue with Mr. Whitlock he has requested that the street name be changed to West Cottage Creek Court.

Staff has not received any negative input on this request. If the request is approved it will be the responsibility of the developer to install a revised street name sign.

Staff is in agreement with this request and recommends approval.



As stated, I am the sole owner of all the lots in the subdivision and none of the individual lots have been sold or are under contract to sell.


