



**PARKS AND RECREATION

**AGENDA ITEMS**

**1. Approve January Minutes — Motion** was made by David Rutter, **seconded** by Jim Grady, **to approve the minutes.** The motion carried; 5-0.

**2. Public Input (No discussion, No action allowed) —.**

Marc Stone, of 609 W. Forest Drive, Payson, AZ 85541 spoke to the Board regarding his home backing up to North Rumsey Park and specifically Rumsey III baseball/softball field. He is very upset and angry that the field is used for games and tournaments for students and adults over the age of 12 that causes foul balls to come into his yard and hit his house. He is concerned about damage to his roof and windows mainly from the fast-pitch high school age girls' tournaments that are held two or three times a year and also the Little League All-Stars when they have adults who come in and do pitching clinics for the kids. He sees the following solutions:

1. Only age 12 and under are allowed on that field and no coach pitching to those kids, limit the pitching machine use.
2. Change to netting up and over home plate.
3. Legal action to restrain use of that field.

He would like help from the Board, Cameron Davis, Director and Nelson Beck, Park Supervisor in resolving this issue to his satisfaction.

**3. Issues and Concerns from the Board (Discussion Only, No action allowed)**

Jim Grady, Board Member is also a Member of the Gila County Meth Coalition and they would like to host a Drive in Movie Night here in Payson to raise awareness in this community. Do we have a venue to host this event?

We do not have the equipment but we do have the venue to host an event like this. They would need to contact a private portable movie business for the screen and equipment.




