

RESOLUTION NO. 2544

A RESOLUTION OF THE MAYOR AND COMMON COUNCIL OF THE TOWN OF PAYSON, ARIZONA, DECLARING AND ADOPTING THE RESULTS OF THE PRIMARY ELECTION HELD ON MARCH 9, 2010, VACATING THE MAY 18, 2010 GENERAL ELECTION, AND DECLARING AN EMERGENCY.

WHEREAS, the Town of Payson, Gila County, Arizona, did hold a Primary Election on the 9th day of March, 2010 for the election of a Mayor, three Council Members and Proposition 300 (Home Rule); and

WHEREAS, the election returns have been presented to and have been canvassed by the Mayor and Common Council of the Town of Payson,

NOW, THEREFORE, THE MAYOR AND COMMON COUNCIL OF THE TOWN OF PAYSON, ARIZONA, DO HEREBY RESOLVE AS FOLLOWS:

Section 1. That Exhibit A, attached hereto and incorporated herein, is adopted as the Official Town of Payson Canvass/Abstract of Vote for the Primary Election of March 9, 2010 and that Exhibit B, attached hereto and incorporated herein, is adopted as the March 9, 2010 Primary Election Summary Report.

Section 2. That the total number of ballots cast at said Primary Election was 5123.

Section 3. That the number of ballots to be verified was 7 and the number of voters found to be ineligible was 6.

Section 4. That the votes cast for the candidates for the office of Mayor were as follows:
