

**RESOLUTION NO. 2549**

**A RESOLUTION OF THE MAYOR AND COMMON COUNCIL OF THE TOWN OF PAYSON, ARIZONA, ADOPTING A FEE SCHEDULE FOR THE PROVIDING OF EMERGENCY FIRE AND MEDICAL SERVICES WITHIN THE CORPORATE LIMITS OF THE TOWN OF PAYSON WHEN ALCOHOL OR DRUGS ARE INVOLVED IN CREATING THE NEED FOR SUCH EMERGENCY SERVICES.**

**WHEREAS**, the Town of Payson (“Town”) provides emergency fire and emergency medical services within its corporate limits; and

**WHEREAS**, the Town may charge a fee for such services; and

**WHEREAS**, in 2001, the Town established a fee schedule for such charges incurred outside its corporate limits; and

**WHEREAS**, it is the intent of the Town to impose charges for such services within its corporate limits when the consumption of alcohol or drugs is involved in creating the need for such emergency services,

**NOW, THEREFORE, THE MAYOR AND COMMON COUNCIL OF THE TOWN OF PAYSON, ARIZONA, DO HEREBY RESOLVE AS FOLLOWS:**

Section 1. That the Town of Payson incurs costs in providing emergency fire and emergency medical services within its corporate limits.

Section 2. In 2001, the Mayor and Common Council approved a fee schedule for the provision of emergency fire and emergency medical services outside the corporate limits of the Town.

Section 3. That the fee schedule attached hereto as Exhibit “A” is hereby adopted for the recovery of costs of providing emergency fire and emergency medical services within the corporate limits of the Town of Payson.

Section 4. That the Town be and is hereby authorized to charge and collect the fees set forth in Exhibit “A” hereof in every case when there is a reasonable suspicion that the recipient of emergency fire and/or emergency medical services violated any provision of Arizona Revised Statutes, Title 28, Chapter 3 at the time of the incident where such services are provided.
