

RESOLUTION NO. 2547

A RESOLUTION OF THE MAYOR AND COMMON COUNCIL OF THE TOWN OF PAYSON, ARIZONA, ADOPTING AN INCREASE IN WATER RATES.

WHEREAS, a written report and data supporting the increased water rates set forth herein has been made available to the public by the filing of a copy thereof in the Office of the Town Clerk at least thirty days prior to the public hearing held on May 6, 2010; and

WHEREAS, pursuant to A.R.S. § 9-511.01(A)(2), at its regular meeting on April 1, 2010, the Mayor and Common Council adopted a Notice of Intention to increase water rates and established May 6, 2010, as the date for public hearing on the proposed increase; and

WHEREAS, at least thirty days have passed since the adoption of said Notice of Intention and scheduling the public hearing; and,

WHEREAS, a copy of the Notice of Intention showing the date, time, and place of such public hearing was duly published in accordance with A.R.S. § 9-511.01(A)(2) in the April 9, 2010 edition of the *Payson Roundup*; and

WHEREAS, the Mayor and Common Council of the Town of Payson have held a public hearing on the proposed water rate increase and have otherwise complied with the requirements of A.R.S. § 9-511.01 and other relevant provisions of law; and

WHEREAS, the Mayor and Common Council of the Town of Payson have determined that the rates set forth in this Resolution are just and reasonable,

NOW, THEREFORE, THE MAYOR AND COMMON COUNCIL OF THE TOWN OF PAYSON, ARIZONA, DO HEREBY RESOLVE AS FOLLOWS:

Section 1. That the water rates set forth below be and are hereby adopted.

Section 2. All other such resolutions and parts of other resolutions in conflict with provisions in this Resolution are hereby repealed to the extent of such conflict.

Section 3. The rates adopted by this Resolution shall be effective July 1, 2010.
