## POSSIBLE MOTION

I move to direct staff to waive the temporary business license requirements for 20-25 vendors for the 18<sup>th</sup> Annual Beeline Cruise-In Auto Show at Green Valley Park on April 29-30, 2011, including associated fees estimated in the amount of \$500.00 to \$625.00.

## SUMMARY OF THE BASIS FOR POSSIBLE MOTION:

Mr. Ken Gunderson, representing the Rim Club Classic Auto Club which sponsors this event, is requesting a waiver of the temporary business license requirements for this event. The Town of Payson Code of Ordinances Section 110.02 makes it unlawful “for any person to carry on any non-exempt business, game or amusement, calling profession or occupation within the municipal limits of the town without having first procured a business license from the town.” Town Code Section 110.10 lists the exemptions to the business license requirements including, but not limited to, religious, charitable or other non-profit organizations, institutions or associations.

The business license fee structure, as set by Council, lists the following:

General Business License (initial)	\$70.00	(Renewal - \$50.00)
Out-of-Town (initial)	90.00	(Renewal - \$70.00)

Recognizing the temporary nature of some businesses conducted in Town, the Town Council passed Resolution 2579 in September, 2010, which allows the issuance of a Temporary Business License for special events, sales events and/or service activities limited to 14 days or less. In addition, the Council set a reduced fee of 25.00 for a Temporary Business License.

Mr. Gunderson has indicated they anticipate 20-25 vendors for this event. The amount of fees to be waived with this request would be \$500.00 to \$625.00.
