## SUMMARY OF THE BASIS FOR POSSIBLE MOTION:

The Phoenix Cannonball Run Classic Car Rally is a fund raiser for "Operation Homefront" which is an Arizona charity devoted to providing emergency financial and other assistance to the families of military members. We received a request from Sue Malinski, coordinator for the Phoenix Cannonball Run Classic Car Rally, to barricade the east bound lane of W. Main Street between Westerly Road and Oak Street to provide temporary on-street parking. The barricading would be in place between 9:30 AM and 11:30 AM on Saturday, April 16, 2011. This is similar to what the Town does now for First Friday. A copy of the letter of request is attached.

Typically, there is a charge for providing this type of service for a private event that is not co-sponsored by the Town. The cost for the man power and equipment to place and remove the barricading is estimated to be \$298.68. This is the amount requested to be waived for this fund raiser.
