

ORDINANCE NO. 816

AN ORDINANCE OF THE MAYOR AND COMMON COUNCIL OF THE TOWN OF PAYSON, ARIZONA, CREATING PAYSON'S AIRPORT COMMISSION BY ADDING SECTIONS 33.25 THROUGH 33.28 TO CHAPTER 33 OF THE CODE OF THE TOWN OF PAYSON.

WHEREAS, the Town of Payson has numerous standing Boards, Committees, and Commissions that act in an advisory capacity to the Town Council; and

WHEREAS, it is the intention of the Town of Payson to create an Airport Commission by adding Sections 33.25 through 33.28 to Chapter 33 of the Code of the Town of Payson relating to Town Boards, Committees, and Commissions; and

NOW, THEREFORE, THE MAYOR AND COMMON COUNCIL OF THE TOWN OF PAYSON, ARIZONA, DO HEREBY ORDAIN AS FOLLOWS:

- Section 1. Sections 33.25 through 33.28 (Airport Commission) of Chapter 33 of the Code of the Town of Payson set forth in Resolution 2641 were heretofore declared to be a public record by such Resolution, and all the provisions thereof are hereby referred to and added to the Code of the Town of Payson and adopted by this reference as though all the provisions thereof were set forth in full in this Ordinance.
- Section 2. That at least three copies of Sections 33.25 through 33.28 (Airport Commission) of Chapter 33, as adopted by this Ordinance shall be filed in the Office of the Town Clerk of the Town of Payson and the same shall be maintained and kept available for public use and inspection.
- Section 3. Pursuant to Section 33.02 of the Code of the Town of Payson, the Airport Commission shall have seven members.
- Section 4. In accordance with Section 33.05 of the Code of the Town of Payson, the Assistant Town Manager in charge of Public Works shall be the staff advisor to the Airport Commission.
- Section 5. The provision of Section 33.02(E) permitting a person to serve on only one Town Board, Committee, or Commission at a time shall not apply to any Payson Regional Airport Authority Board Member who is appointed as an initial member of the Airport Commission and is serving on another Town Board, Committee, or Commission at the time of such appointment. If a person to whom this section applies resigns or is not reappointed to a Town Board, Committee, or Commission, the provisions of this section shall no longer apply to such person.

Section 6. On or before December 31, 2012, the Airport Commission shall review and make recommendations to the Town Council on amendments to Chapter 95 (Airport) of the Code of the Town of Payson

Section 7. If any section, subsection, sentence, clause, phrase or portion of this Ordinance is for any reason held to be invalid or unconstitutional by the decision of any court of competent jurisdiction, such decision shall not affect the validity of the remaining portions of this Ordinance. The Mayor and Common Council of the Town of Payson declares that it would have adopted this Ordinance and each section, subsection, sentence, clause, phrase or portion thereof despite the fact that any one or more sections, subsections, sentences, clauses, phrases or portions would be declared invalid or unconstitutional.
