## F. ITEMS FOR DISCUSSION/POSSIBLE ACTION

### 1. ASU Brainstorming

*PAAYC's main goal with ASU is to collect data from the schools about youth opinion on the subject. A survey is to be drafted by the council members that addresses the students' interest level in having a 4-year university in Payson and the possibilities of an economic boom in the town with the arrival of new business. The surveys are to go to Payson High School and Gila Community College. Council member Anthony Smith moved that the ASU study officially begin and it was seconded by Lauren Best followed by a unanimous vote in favor.*

### 2. Payson Food Drive

*The Payson Area Food Drive will go until Superbowl Sunday. Roger Kreimeyer approached the council with plans to have Woody (The Payson Area Food Drive mascot) make an appearance at the electric light parade on December 3rd and council member Anthony Smith decided that he would drive the truck that Woody would stand in. PAAYC received the \$15 entry fee for the parade from Roger Kreimeyer. There will be a pre-parade meeting on November 29th at 5:30 PM at the public library. Volunteers are needed to be in the Woody costume and stand on the corner for Turkey Tuesday and Andrew Hensley, along with various council members, decided they would help on 11/22 at the times they were available. Finally, a motion was made by Anthony Smith and seconded by Lauren Best that PAAYC officially partner with NHS at the high school for the food drive. The vote passed unanimously.*

### 3. Distracted driving prevention

*It was said that PAAYC will plan to contact higher-up individuals in Arizona to help move a distracted driving bill through and that in the meantime they will be working on local research. This research will include a survey taken at the high school. A survey will be drafted by Vice-Chairperson Austin Shannon regarding distracted driving and it will be delivered to the school as soon as possible. Discussion was made of separate groups of PAAYC members that would take up various aspects of the research (i.e. research, data collection, assembly, and presentation). Council member Lauren Best motioned for PAAYC's official support of distracted driving legislation in Arizona. This was seconded by council member Anthony Smith and the vote passed unanimously.*




