

RESOLUTION NO. 2678

A RESOLUTION OF THE MAYOR AND COMMON COUNCIL
OF THE TOWN OF PAYSON ADOPTING THE GILA
COUNTY MULTI-JURISDICTIONAL HAZARD MITIGATION PLAN 2011

WHEREAS, the Town of Payson would like to adopt the Gila County Multi-Jurisdictional Mitigation Plan ("Plan") to meet the requirements of the Disaster Mitigation Act of 2000 ("DMA2K"); and

WHEREAS, the Town of Payson has experienced damage from natural and human caused hazards such as drought, flooding, and wildfire, possibly resulting in damage and/or loss of property and life, economic hardship and threats to public health and safety; and

WHEREAS, the Plan has been drafted pursuant to Federal requirements, having been developed with research and work done by the Town of Payson in association with the Gila County Multi-Jurisdictional Planning Team, for the reduction of hazard risk to the community; and

WHEREAS, the primary purpose of the Plan is to identify hazards that affect the Town of Payson, assess the vulnerability and risk posed by those hazards to community-wide human and structural assets, developing strategies for mitigation of those identified hazards, present future maintenance procedures for the Plan, and document the planning process, and

WHEREAS, the Plan recommends several hazard mitigation actions or projects that will provide mitigation for specific hazards that affect the Town of Payson, in order to protect people and property from loss associated with those hazards; and

WHEREAS, upon approval of the Plan and approval from the Arizona Division of Emergency Management and the Federal Emergency Management Agency, the Town of Payson will be eligible to apply for federal mitigation grant funding.

NOW THEREFORE, THE MAYOR AND COMMON COUNCIL OF THE TOWN OF PAYSON DO HEREBY RESOLVE AS FOLLOWS:

- Section 1. That the Gila County Multi-Jurisdictional Mitigation Plan 2011 is hereby adopted.
- Section 2. That the Plan shall be implemented, monitored, and maintained by the officials/staff designated in the Plan.
- Section 3. That Town Staff is authorized to take any other actions necessary to carry out the intent of this Resolution.


