We, the undersigned, the owners of one-half or more in value of the real and personal property and more than one-half of the persons owning real and personal property that would be subject to taxation by the Town of Payson in the event of annexation within the territory proposed to be annexed, which is hereafter described, said territory being contiguous to the corporate limits of the Town of Payson, with the exterior boundaries of the territory proposed to be annexed shown on the map attached hereto, marked Exhibit 'A', request that the Town of Payson annex the territory described below, provided that the requirements of A.R.S. §9-471 are fully observed.

The southeast quarter of the northeast quarter of Section 7, Township 10 North, Range 11 East of the Gila and Salt River Meridian;






