PURPOSE OF MEETING: Budget for FY 2015/2016

1. Property Tax:

This is a public hearing. Council Decision Request filed by Hope Cribb, Finance Manager, setting forth the Primary Tax Levy for the Fiscal Year 2015/2016. The Town received the Preliminary 2015 Levy Limit Worksheet from the Gila County Assessor's Office in March. The Preliminary Worksheet was used to calculate the maximum rate and amount that could be assessed. The maximum amount the Town can assess is \$711,910. The maximum assessable rate, without exceeding the Truth in Taxation hearing statute is 0.3877 per \$100/assessed value or \$651,115. **This is a public hearing**
