

2010/2011 FEE and CHARGES SCHEDULE

Per Resolution 2554, Effective July 1, 20

The fee schedule for the Town of Payson, which is to be enacted on July 1, 2010, shall be as follows, subject to administration fees and outside costs where applicable.

- ADMINISTRATION FEE:** An administration fee of 10% may be added to all fees and charges listed herein whenever outside costs are incurred.
- OUTSIDE COSTS:** Outside costs are generally all costs of services and materials billed to the Town and shall include but are not limited to costs of publication and posting; attorney fees; filing fees; reproduction costs; outside engineering, surveying and consulting services.
- DEPOSITS:** **With the exception of Water Department deposits:**
All deposits required in this resolution shall be held for a period of not to exceed three (3) months from the date of completion of the project to allow for all billings related to the event to be received by the Town and billed against the deposit. Deposits are meant to reimburse the costs involved. When costs exceed the original deposit, an additional deposit will be required before any further work will be performed by the Town. The amount of the additional deposit shall be determined by the Town. No interest shall accrue to any deposit.
- REFUNDS:** Except as may be noted otherwise, fees and charges are non-refundable.

PERMITS

The Town shall calculate the building valuation data as required by any code adopted pursuant to this chapter by utilizing the most current building valuation data as determined from time to time, and published by the International Code Council.

SINGLE FAMILY RESIDENTIAL FEES

A) New Single Family Residential **Construction Fee** shall be calculated using the following fee per square foot of area: See Valuation Table 3-A

Non-Living Space	0.23
Garage Space	0.23
Covered Deck Space	0.12

B) **Single Family Residential Plan Review Fee**

The initial plan review fee will be calculated at a rate of 46% of all the elements of the Building Permit Fee (calculated in step A). Additional plan review, if needed, will be charged at a rate of \$25.00 per 1/2 hour. Expedited plan review will be charged at a rate of \$25.00 per 1/2 hour.

C) Add the fee from step A and the calculation in step B for the total building permit fee.

- D) Plan Review fees are calculated by multiplying the Building Permit fee by 65%.

Expedited plan review will be charged at a rate of \$25.00 per 1/2 hour. (Expedited plan review fees MUST be arranged for in advance and are charged in addition to all other fees).
